1. After arguing these appeals for some time, counsel for the appellants sought permission to withdraw these appeals as also the Misc. Applications with liberty to file fresh appeals and fresh Misc. Applications by incorporating additional grounds and additional documents which according to the counsel were inadvertently not annexed to the appeals.

2. It is relevant to note that these appeals were partly heard on February 28, 2018 and again heard today extensively. Seeking permission to withdraw these appeals as also the Misc. Applications at this belated stage is wholly unjustified. However, in the interest of justice, we permit withdrawal of these appeals as also the Misc. applications with liberty to

file fresh appeals as also Misc. Applications subject to payment of costs of Rs. 25,000/- to be paid by each appellant to SEBI within a period of two weeks from today.

3. Fresh appeals with Misc. Applications, if any, be filed within a period of three weeks from today. If fresh appeals with Misc. Applications are filed within a period of three weeks from today and costs are paid within two weeks from today, then the court fees paid on these appeals shall be adjusted toward the court fees payable on the fresh appeals that may be filed by the appellants.

4. All the appeals are disposed of in the aforesaid terms.
